Dr. Barry Goldlist Receives Prestigious Award at CGS Conference

At this year's Canadian Geriatrics Society (CGS) Conference, hosted April 14-16 in Vancouver, **Dr. Barry Goldlist** was honoured for his ongoing contributions to advancing geriatric medicine in Canada and received the Ronald Cape Distinguished Service Award.

Throughout his career to date, Dr. Goldlist has helped to champion developments in geriatrics and is a tireless advocate for seniors.

Since lending his skills to the preliminary planning sessions that preceded the formation of CGS, where he first met the award's namesake Dr. Ronald Cape, Goldlist has continued to be a respected fixture at the society's conference, missing only one annual meeting due to a direct conflict with a family wedding. He would next cross paths

with Dr. Cape who was the chief examiner when Dr. Goldlist became the eighth person to receive a

certificate of special competence in geriatrics from the Royal College of Physicians and Surgeons of Canada (RCPSC).

In his acceptance speech, Goldlist provided some insight as to the value of elder care in our society, noting that "society owes a duty of care to our older citizens... as individual[s], and as a society, [we] benefit greatly from the older people in our midst". He also

acknowledged some of the lessons he has learned from engaging his patients to share their own oral history, serving as reminder of the incredible wealth of non-medical knowledge patients have. One of his most memorable lessons in local history was revealed in conversation with a 95 year-old patient, who was in hospital with a fractured vertebra; as a friend of the Eaton family's chauffeur, he drove and nearly destroyed the first car in Toronto!

A full Professor within UofT's Department of Medicine, Dr. Goldlist has also served as Chief Examiner in Geriatrics, Chair of the Specialty Committee in Geriatrics of the RCPSC and as a past CGS President. His experience has also been integral to the development of the Geriatric Medicine subspecialty program; he served as the Division Director for 14 years and continues to supervise trainees and is an active member of several committees and working groups. Often cited, he has also written three books, several chapters and over 70 articles. Other awards include the Munk Award in Geriatric Medicine (Baycrest) and the Detweiler Award (RCSPC).

Trainees Shine at CGS Conference

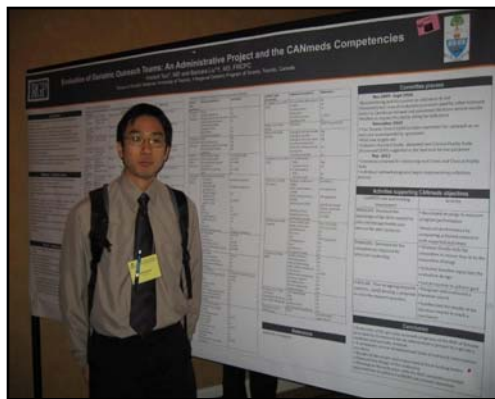
Geriatric Medicine trainees had a strong presence at this year's CGS conference.

Dr. Joanne Ho, who successfully completed her term as a Geriatric Medicine trainee in December 2010 at Sunnybrook, continues to keep busy having just passed the second stage of her Clinical Epidemiology Masters of Science at UofT's Department of Health Policy Management and Evaluation.

The Masters program provides Joanne the opportunity to further develop her research skills and apply her knowledge in a meaningful way to improve patient outcomes. Joanne has a true passion for research and when asked what inspired her to pursue this program, she mentioned that she often-times encounters interesting questions through her own clinical work and

tries to find answers by either searching the literature for previous studies or by conducting her own self-directed project. Currently, she is involved with several projects regarding drug-related adverse cardiac events on older Ontario patients.

As a CIHR Training Fellow, Dr. Ho has also been awarded funding (actual amount TBA) through the Drug Safety and Effectiveness Cross-Disciplinary Training (DSECT) Program. Successful candidates are awarded up to \$17,500 and participate in a 1-year program designed to encourage production of new knowledge and integrative critical thinking.
